
**TO ALL CONTRACT CLEANING EMPLOYERS THROUGHOUT KZN**

On the 17<sup>th</sup> February 2020 the Minister of Labour amended the National Minimum Wage by way of a promulgation through the Government Gazette No 43026

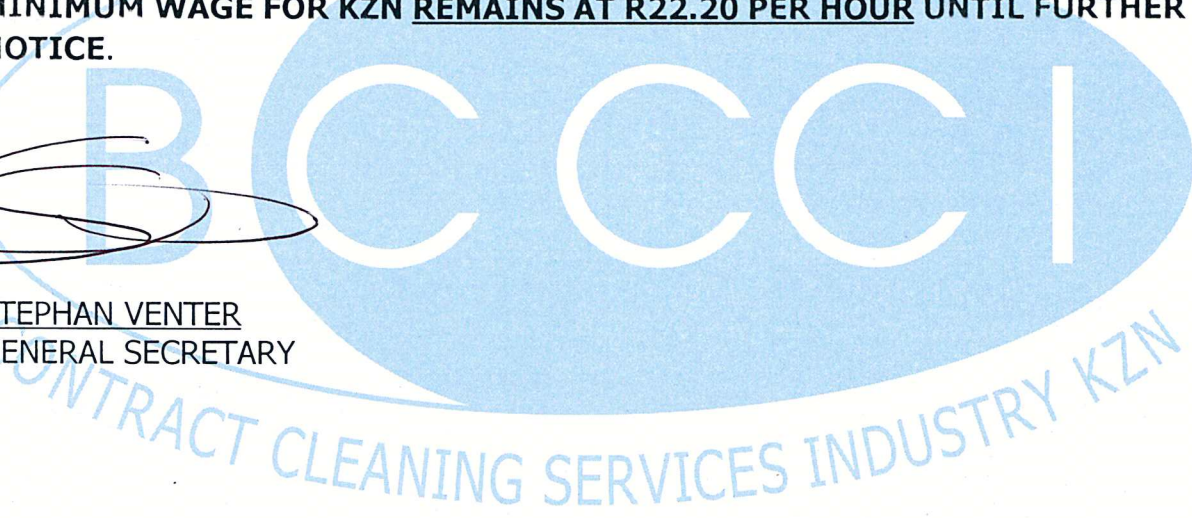
The promulgation furthermore provided under schedule 2 for changes in the Sectoral Determination 1: Contract Cleaning and it provides inter alia under table 1, "minimum hourly rate for Contract Cleaning Employees" area B, KZN, the minimum rate to be R23.04 per hour.

THE CONTRACT CLEANING SERVICES BARGAINING COUNCIL'S MAIN COLLECTIVE AGREEMENT HAS BEEN EXTENDED UNTILL 30<sup>TH</sup> AUGUST 2020

IN VIEW OF THE ABOVE, PLEASE BE ADVISED THAT THE DETERMINATION PUBLISHED BY THE OFFICE OF THE MINISTER OF LABOUR DEALING WITH CONTRACT CLEANING IN KZN DO NOT APPLY TO THE BARGAINING COUNCIL FOR THE CONTRACT CLEANING SERVICES INDUSTRY THROUGHOUT KZN AND **THE MINIMUM WAGE FOR KZN REMAINS AT R22.20 PER HOUR UNTIL FURTHER NOTICE.**


